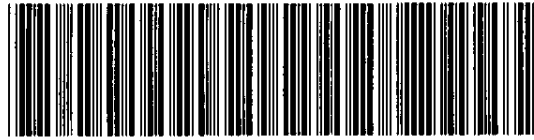

1. Article I of the Articles of Incorporation of Smith, Feddeler, Smith & Miles, P.A. is hereby amended to read as follows:

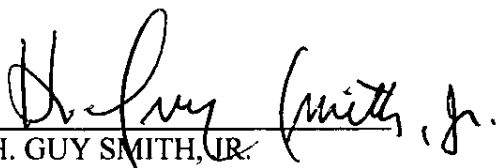
ARTICLE I. NAME
