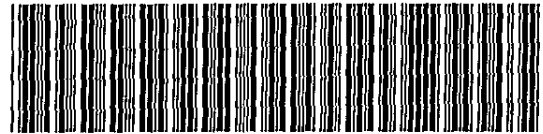

The corporation was dissolved on March 31, 2003.

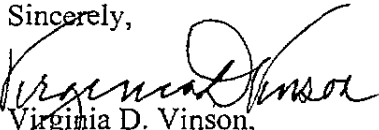
