ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF HALLIDAY PRODUCTS, INC.

ARTICLE IV CAPITAL STOCK

The Corporation is authorized to issue the following two (2) classes of stock:

13,500 shares of Class A Voting Common Stock

\$.01 Par Value

1,336,500 shares of Class B Non-Voting Common Stock

\$.01 Par Value

The Class A Voting Common shares shall be the only shares entitled to the privilege of voting. In all other respects the Class A Voting Common Stock and Class B Non-Voting Common Stock shall have the exact same rights.

SECOND: The foregoing Amendment was adopted by a Written Action of the Shareholders and Directors of Halliday Products, Inc. on April 27, 1999 which manifests an intent to amend the Articles of Incorporation effective upon the filing of this Amendment with Secretary of State.
