ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Chapter 607.1001 et seq., Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST

Article 1 of the Articles of Incorporation of the corporation is hereby amended in its entirety to read as follows:

"ARTICLE 1


The name of the corporation shall be: PRN, INC."
