

**ARTICLES OF DISSOLUTION

Pursuant to Section 607.1403, Florida Statutes, **SCAN-AM MARINE SERVICES, INC.**, a Florida corporation submits the following articles of dissolution:

1. The name of the corporation is **SCAN-AM MARINE SERVICES, INC.**, (the "Corporation").
2. The Articles of Incorporation for the Corporation were filed on November 1, 1978 with the Secretary of State of the State of Florida (Document No. 591986).
3. Shareholders representing 100% of the issued, outstanding shares of the Corporation attended a duly called meeting of the Shareholders held on November 1, 2022 ("Meeting"). The dissolution of the Corporation was approved unanimously by the Shareholders at the Meeting in the manner required by Section 607.1403, Florida Statutes, and the Bylaws of the Corporation. The Effective Date of the dissolution of the Corporation shall be December 31, 2022.
4. All debts, obligations and liabilities of the Corporation have been paid or discharged. This Corporation is solvent and has no outstanding debts, and its dissolution will not affect the rights of any creditor whatsoever.
5. All remaining property and assets have been distributed among its Shareholders in accordance with their respective rights and interests.
6. There are no suits pending against the Corporation in any court.
7. The Corporation shall cease and close all of its business, operation and activities.
8. Robert Birdsong is hereby authorized and directed to sign, execute, endorse, deliver, and file, for and in behalf of the Corporation, all the necessary documents and other supporting papers to be filed with the Secretary of State, as well as do all acts or things necessary to carry into effect the dissolution of the Corporation and wind up its affairs.
9. These Articles of Dissolution shall be filed in the Office of the Secretary of State of Florida.


