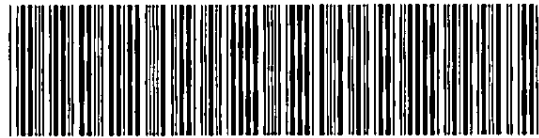

**Amendment**

Article IV is hereby amended to read as follows:


**ARTICLE IV – CAPITAL STOCK**

The maximum number of shares of stock that the corporation shall have authority to issue is 1,300,000 shares of \$.01 par value Common Stock.
