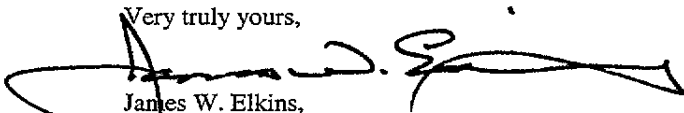

SECOND: Dissolution of the Corporation was recommended by all the directors to the shareholder on 3 October 2000.

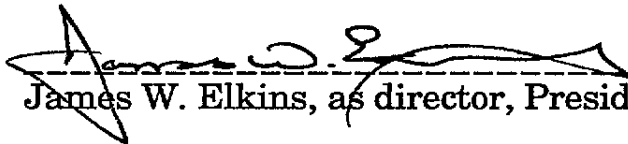
