Dear Division of Corporations:

On September 27, 1999, The Travel Center of Tallahassee, Inc. (TTC) signed an agreement with Adventures in Travel of Tallahassee, Inc. (AIT) for the sale of selected assets of TTC to AIT.

The closing occurred on November 5, 1999 to be effective as of November 8, 1999. At that time, the location at 703 North Monroe Street, Tallahassee, FL 32303, ceased to be a functioning location for The Travel Center of Tallahassee, Inc.

Another tenant leased the 703 North Monroe Street location from the landlords. While we filed a forwarding address with the post office to forward all our mail to P.O. Box 3607, Tallahassee, FL 32315. We never received any filing forms after the documents that kept us as an active corporation after the 2000 filing.

It has been our intent to retain the corporation as an active entity at least until AIT had met all its obligations to TTC.

As directed by your office, enclosed is our check no 14035 in the amount of \$300.00 to request reinstatement of the corporation to a continuing active status.
