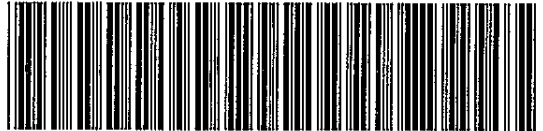

ARTICLES I - NAME OF CORPORATION

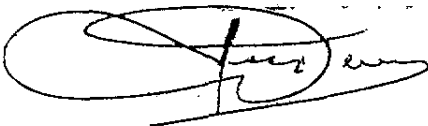
The name of the corporation is **SUJOTA, INC.** hereinafter referred to as the "Corporation".
