

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF DRS. ELLIS, ROJAS, ROSS & DEBS, INC.



July 13, 2022

Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, DRS. ELLIS, ROJAS, ROSS & DEBS, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article VII of the Corporation's Articles of Incorporation is deleted in its entirety and replaced with the following new Article VII:

## "ARTICLE VII - NUMBER OF DIRECTORS

This Corporation shall be managed by a Board of Directors and shall have at least one (1) director. The number of directors may be either increased or decreased from time to time as provided in the Corporation's Bylaws, but shall never be less than one (1) nor more than fifteen (15)."

- 3. - 4. The effective date of this Amendment shall be upon the filing of these Articles of Amendment.
