Pursuant to the Florida Business Corporation Act, Article III of the Articles of Incorporation of WINSLOW, SNEIDER, PRYOR AND MESSINGER RADIOLOGICAL ASSOCIATES P.A., a Florida corporation, hereinafter referred to as the "Corporation", is amended to read as follows:

**ARTICLE III.
CAPITAL STOCK**

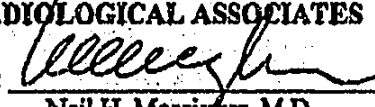
This corporation shall be authorized to have a maximum of Ten Thousand (10,000) shares of stock outstanding at any one time. The shares of stock authorized shall be common stock having a par value of Five (5) Dollars per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

In accordance with Section 607.0123(1)(b) of the Florida Business Corporation Act, this Amendment shall be effective as of the date of the filing of this Amendment.

The foregoing Amendment to the Articles of Incorporation of the Corporation was proposed and approved at a special meeting of the shareholders on August 4, 1997, pursuant to Section 607.0704 of the Florida Business Corporation Act.

IN WITNESS WHEREOF, the undersigned President of the Corporation has executed these Articles of Amendment this 18th day of August, 1997.

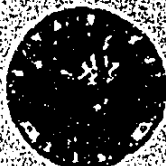
