THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Incorporation of **RADIOLOGY ASSOCIATES OF SOUTH FLORIDA, P.A.**, a Florida professional service corporation (the "**Corporation**"), pursuant to the Professional Service Corporation and Limited Liability Company Act (Chapter 621 of the Florida Statutes) and the Florida Corporation Business Act (Chapter 607 of the Florida Statutes):

1. Name of Corporation. The name of the Corporation is **RADIOLOGY ASSOCIATES OF SOUTH FLORIDA, P.A.**

2. Date of Filing of Articles of Incorporation. The Corporation filed its Articles of Incorporation with the Florida Department of State on June 21, 1968 (the "**Articles**").

3. Amendment to Articles of Incorporation.

(a) Article I of the Corporation's Articles is hereby amended by deleting the current text of Article I in its entirety and substituting the following in lieu thereof:

*"Article I. Name. The name of this corporation is **Radiology Associates of South Florida, Inc.** and it shall be formed as a corporation under Chapter 607 of the laws of the State of Florida."*

(b) Article II of the Corporation's Articles is hereby amended by deleting the current text of Article II in its entirety and substituting the following in lieu thereof:

*"Article II. Purpose. The Corporation is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a Florida corporation under the laws of the State of Florida."*

4. Effective Date. These Articles of Amendment to Articles of Incorporation of the Corporation shall be effective August 21, 2017.

5. Adoption of Amendment. The amendment was adopted by written consent of the Board of Directors and shareholders of the Corporation on August 21, 2017. The number of votes cast for the amendment by the shareholders was sufficient for approval.
