ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OB/GYN SPECIALISTS OF THE PALM BEACHES, P.A.

The undersigned corporation, in accordance with the Florida Business Corporation Act and its Bylaws, hereby adopts the following Articles of Amendment:

1. The name of the Corporation is OB/GYN Specialists of the Palm Beaches, P.A.
2. The Articles of Incorporation were filed with the Florida Department of State effective November 27, 1968, and the Florida document number assigned to this Company is 600608.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE I.  
NAME

"The name of the Corporation shall be OB/GYN SPECIALISTS OF THE PALM BEACHES, INC."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.
5. These Articles of Amendment have been approved by unanimous Written Action of the Directors and Shareholders of the Corporation effective as of December 27, 2017, which vote is sufficient for approval.
6. Except as expressly provided herein, all of the terms and provisions of the Articles of Incorporation shall remain in full force and effect and are hereby ratified and confirmed.
