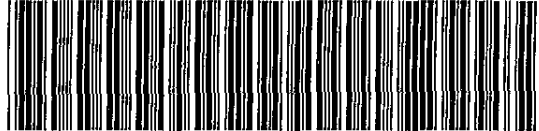

Articles of Dissolution


