IN WITNESS WHEREOF, the undersigned president of the corporation has executed these Articles of Amendment on April 11, 1997.

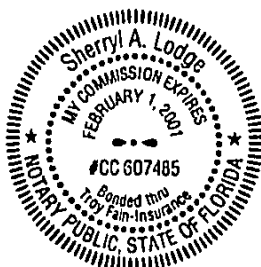
