



AMENDMENT TO THE ARTICLES OF INCORPORATION OF ROGERS, BOWERS, DEMPSEY AND PALADINO, P.A.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the Articles of Incorporation of ROGERS, BOWERS, DEMPSEY AND PALADINO, P.A. (the "Corporation") are hereby amended as follows:

FIRST: Article III of the Corporation's Articles of Incorporation is deleted in its entirety, and in its place and stead, the following is substituted:

""ARTICLE I - NAME

The name of the Corporation is ROGERS, DEMPSEY & PALADINO, P.A."

SECOND: These Articles of Amendment shall become effective on the date that the Articles are filed with the Secretary of State of the State of Florida.

THIRD: These Articles of Amendment were approved by the Board of Directors and by the shareholders of the Corporation by unanimous written consent on December 31, 2002.
