Pursuant to the Florida Business Corporation Act, **Biemer, Packer & Carta, P.A.**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

ARTICLE I
Name

The name of the Corporation is **ASSOCIATED PATHOLOGISTS, P.A.**

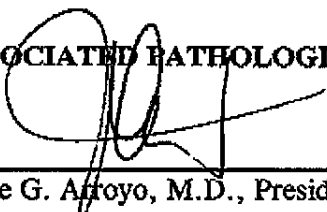
