6. The effective date of these Articles of Dissolution is April 15, 2002.

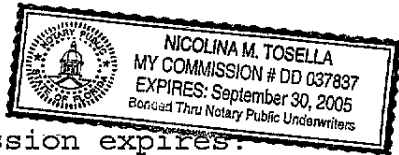
