**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
CLARK & DAUGHTREY MEDICAL GROUP, PROFESSIONAL ASSOCIATION  
(Document Number 601409)**

Pursuant to Sections 607.1006 and 621.13, Florida Statutes, the undersigned Florida professional service corporation, pursuant to a resolution duly adopted by the written consent of its Directors on August 1, 2013, hereby amends its Articles of Incorporation as follows:

1. First, Article I is hereby amended to replace the current language with the following:

**ARTICLE I**

The name of this corporation shall be CLARK & DAUGHTREY MEDICAL GROUP, INC.

2. Next, Article II is hereby amended to replace the current language with the following:

**ARTICLE II**

This corporation is organized for the purpose of transacting any and all lawful business.


3. Next, the following is added to Article XIII:

**ARTICLE XIII**
