ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MCLIN & BURNSED P.A.

Pursuant to Sections 607.1006, *Florida Statutes*, McLin & Burnsed P.A., a Florida corporation (the "Corporation"), adopts the following amendment to its Articles of Incorporation, which were filed on October 30, 1969 and bear Florida Document No. 601621.

FIRST: Article XII of the Articles of Incorporation, entitled BY-LAWS, shall be deleted in its entirety and replaced as follows:

ARTICLE XII. BY-LAWS

The stockholders or the Equity Board of Directors of this corporation shall have the sole power to establish; enact, alter or repeal By-Laws for the management of this corporation, and the duties of the officers of this corporation shall be prescribed by such By-Laws.

SECOND: The remaining provisions of the Articles of Incorporation shall remain unchanged.

THIRD: This Amendment was unanimously approved by all Shareholders and Directors of the corporation.

FOURTH: The effective date of this Amendment is March 15, 2012.

FIFTH: The date of adoption of these Amendments is March 15, 2012.
