
**ARTICLES OF AMENDMENT

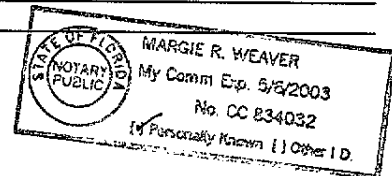
