Pursuant to Sections 607.1001 and 607.1006 of the Florida Business Corporation Act, PENSACOLA PATHOLOGISTS, P.A., a Florida professional corporation (the "Corporation"), hereby submits these Articles of Amendment for the purpose of amending its Amended and Restated Articles of Incorporation as follows:

1. The name of the Corporation is PENSACOLA PATHOLOGISTS, P.A.
2. The document number for the Corporation is 601775.
3. The Amended and Restated Articles of Incorporation are hereby amended by amending Article I to read as follows:

ARTICLE I - NAME

The name of the Corporation is: VIVID PATHOLOGY, P.A.
