Pursuant to Sections 607.1001, 607.1004, 607.1006 and 607.1009, Florida Business Corporation Act and Chapter 621 of the Professional Service Corporation and Limited Liability Company Act, the following provisions of the Articles of Incorporation of DRS. NICHOL, PHILLIPS, ELIAS, SAYFIE AND WORTHINGTON, P.A., a Florida professional corporation, filed in Tallahassee, Florida on December 29, 1969, as thereafter amended, be and they hereby are further amended in the following particulars: —

Article 1, Section 1.1 ("Name") be and it is hereby amended to read in its entirety as follows:

Section 1.1 Name. The name of the corporation is DRS. NICHOL, PHILLIPS, ELIAS, SAYFIE AND CASSIS, P.A. (the "Corporation").

The foregoing amendment was adopted by the shareholders of the corporation on the 08 day of October, 2002. The only voting group entitled to vote on the adoption of the Amendment consists of the holders of the corporation's common stock. The number of votes cast by such voting group was sufficient for approval by that voting group.
