Pursuant to the provisions of Section 607.1006, Florida Statutes, Fowler White Boggs Banker P.A., a Florida professional corporation (the "Corporation"), hereby adopts the following amendment to the Corporation's Articles of Incorporation:

1. The name of the Corporation is Fowler White Boggs Banker P.A.
2. Article I of the Corporation's Articles of Incorporation is hereby amended by deleting it in its entirety and inserting in lieu thereof the following:

"Article I  
Name

The name of this corporation is Fowler White Boggs P.A."

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
4. The amendment hereby made to the Articles of Incorporation was approved by the Corporation's shareholders on November 3, 2008. The number of votes cast for the amendment by the shareholders was sufficient for approval.
