Upon the written consent and proposal of the Board of Directors of the association, the following resolution was unanimously adopted by the Board of Directors and by all Stockholders entitled to vote, by written instrument dated OCTOBER 4, 2018 (the number of votes cast for the amendment by the Stockholders entitled to vote was sufficient for approval), to-wit:

RESOLVED, that, effective on the date of filing with the Florida Department of State, the Articles of Incorporation of JONES, FOSTER, JOHNSTON & STUBBS, P.A., as approved and filed in the office of the Secretary of State at Tallahassee, Florida, on June 1, 1970, as amended, be further amended by striking Article I thereof in its entirety and by substituting therefor the following:
