Pursuant to the provisions of Section 607.1402 and 607.1403 of the Florida Business Corporation Act, **RUDEN MCCLOSKEY P.A.**, a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: **RUDEN MCCLOSKEY P.A.** The Document Number of the Corporation is 602575. The filing date of the Articles of Incorporation of the Corporation was December 7, 1970.
2. The dissolution of the Corporation was authorized by the United States Bankruptcy Court for the Southern District of Florida, pursuant to the *Order Confirming Amended Joint Chapter 11 Plan of Liquidation of Ruden McClosky P.A.*, dated October 11, 2012, entered in the chapter 11 bankruptcy case of *In re Ruden McClosky P.A.*; Case No. 11-40603-BKC-RBR.
3. In accordance with the Florida Business Corporation Act, the dissolution of the Corporation shall be effective upon filing of these Articles of Dissolution with the Florida Department of State.
