The following provision of the Articles of Incorporation of **EDWIN A. BIRNS, D.D.S., P.A.**, a Florida professional service corporation ("Corporation"), filed with the Department of State on February 15, 1971, Charter Number 602695, be, and it is hereby, amended as shown below:

Article I of the Articles of Incorporation of this Corporation is amended to read in its entirety as follows:

**ARTICLE I**

**NAME OF CORPORATION**

The name of this Corporation shall be:

**EDWIN A. BIRNS, D.D.S., INC.**

Additionally, said Articles of Incorporation are hereby modified in all necessary respects to reflect that as of February 12, 1998, this Corporation shall no longer be a corporation organized under the Professional Service Corporation Act, but rather shall be corporation organized under the Florida Business Corporation Act, with the power to transact any lawful business thereunder.

The foregoing amendment was adopted by a Joint Corporate Action of the sole Shareholder and the sole Director of this Corporation, on February 12, 1998.
