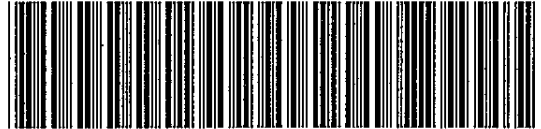

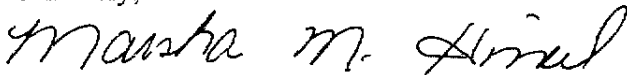

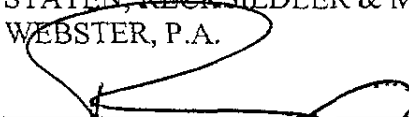

The foregoing was adopted by the Shareholders of this corporation on September 17, 2004.

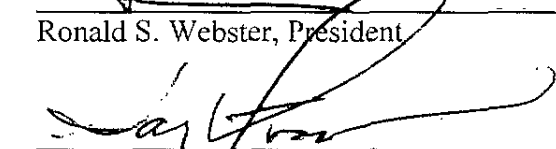

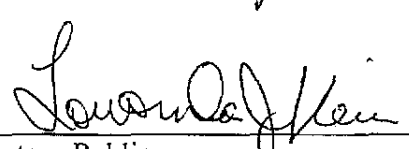
