Pursuant to Florida Statutes Section 607.187 and Section 621.13, the Articles of Incorporation of the above named corporation are hereby amended as follows:

1. The name of the corporation is BRINSON, SMITH, SMITH & STARR, P.A.
2. The following amendments of the Articles of Incorporation were adopted by the stockholders and directors of the corporation on January 31, 1994, in the manner prescribed by the Florida General Corporation Act:

Article I is hereby amended to read as follows:

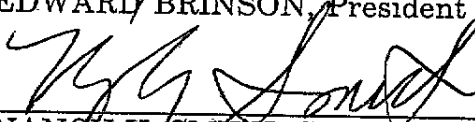
The name of this corporation shall be

4. The number of shares voted for the amendment was 1,500; and the number of shares voted against the amendment was 0.

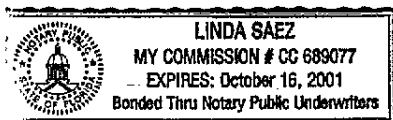

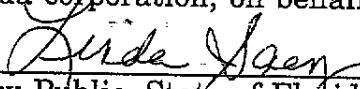
