2. Article I is amended to read:

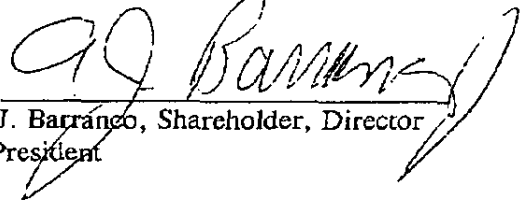
The name of the corporation is A. J. Barranco & Associates, P.A.
