#### ITEM I.

Article III of the Articles of Incorporation of KORNREICH, CASEY, CROSLAND & BRAMNICK, P.A. is hereby amended to read:

#### ARTICLE III.

#### CAPITAL STOCK

The capital of the corporation shall be One Thousand (\$1,000) Dollars, represented by One Thousand (1,000) shares of capital stock, divided into Eight Hundred (800) shares of Class A common stock, One Dollar (\$1.00) par value per share, and Two Hundred (200) shares of Class B common stock, One Dollar (\$1.00) par value per share.

The Class A common stock shall have full voting rights on the basis of one vote per share.

The Class B common stock shall have no voting rights.

Except as to voting rights, the Class A common stock and Class B common stock shall be equal in all respects.

Upon filing of these Articles of Amendment, each share of issued and outstanding common capital stock shall automatically be deemed converted to a share of Class A common stock.
