**WHEREAS**, the Articles of Incorporation of J. SPINGARN, D.D.S., P.A. (the "Corporation") were filed with the Florida Department of State on September 11, 1973; and

**WHEREAS**, the name of the Corporation was changed to "J. SPINGARN AND R. CHERRY, D.D.S., P.A." pursuant to the Articles of Amendment to Articles of Incorporation filed with the Florida Department of State on August 15, 2002 (the "Articles of Amendment").

**NOW, THEREFORE**, pursuant to the provisions of section 607.1006, Florida Statutes, the Articles of Incorporation of the Corporation are further amended, as follows:

1. The name of the Corporation is "JOSEPH H. SPINGARN, D.D.S., P.A."
2. The Shareholders' Agreement dated August 7, 2002 referenced in the Articles of Amendment dated August 7, 2002 is terminated, effective as of August 27, 2004

The amendments set forth above were approved by the Corporation's Board of Directors, on September 29, 2004. Such amendments were approved and properly adopted by the Corporation's Shareholders on September 29, 2004. The number of votes cast for such amendments by the Shareholders was sufficient for approval.
