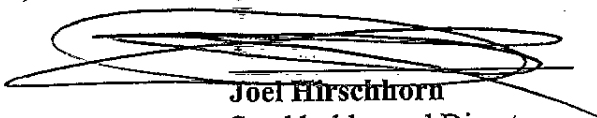

ARTICLE I – NAME

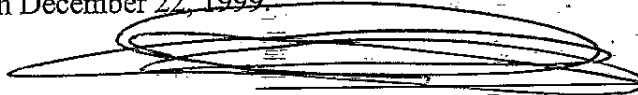
The name of the Corporation is **Hirschhorn & Bieber, P.A.**

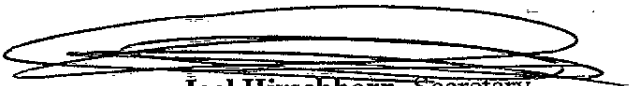

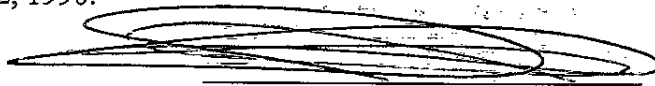

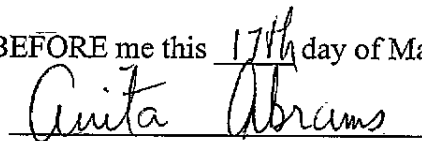
