TO THE ARTICLES OF INCORPORATION OF
LANE, TROHN, CLARKE, BERTRAND, VREELAND & JACOBSEN, P.A.

Pursuant to the provisions of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is LANE, TROHN, CLARKE, BERTRAND, VREELAND & JACOBSEN, P.A.

2. The following amendment to the Articles of Incorporation was adopted by the shareholders and directors of the Corporation on June 4, 1997, in the manner prescribed by the Florida Business Corporation Act:

Article I of the Articles of Incorporation is amended to change the name of the Corporation to LANE, TROHN, BERTRAND & VREELAND, P.A., effective June 10, 1997.

3. The foregoing amendment was adopted by majority vote of the shareholders and board of directors of the corporation pursuant to Florida Statutes §607.1003. There are no voting groups entitled to vote separately on the amendment.

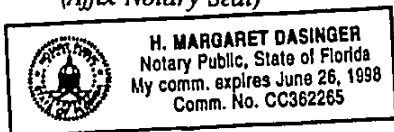
