(b) Paragraph the FIRST of the Articles of Incorporation is amended to read as follows:

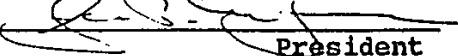

3. The above amendment was adopted on the 13th day of December, 1996, to become effective at 12:01 a.m. on January 1, 1997.

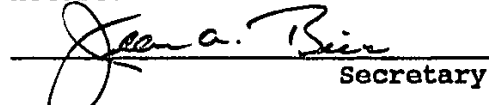
