2. Article I, Name and Principal Office of Corporation, is hereby amended to read as follows:

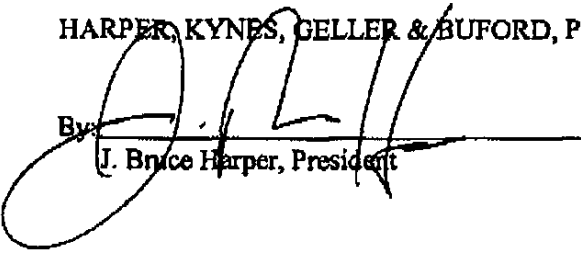
"ARTICLE I - NAME AND PRINCIPAL OFFICE OF CORPORATION
