The name of this corporation is SAMUEL G. ROSENTHAL, M.D., P.A.


ARTICLE II


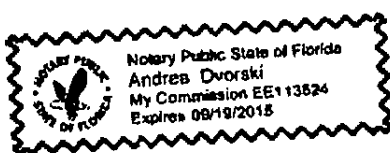
