Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Certificate of Incorporation:

FIRST: The name of the Corporation is **Bigham Cable Construction, Inc.**

SECOND: Paragraph 4. of the Articles of Incorporation of **Bigham Cable Construction, Inc.**, a Florida corporation, is deleted in its entirety and in its place and stead the following is inserted:

4. The Corporation shall have the authority to issue ten thousand (10,000) shares voting common stock at no par value and ten thousand (10,000) share of non-voting common stock at \$.01 par value.

THIRD: The date of adoption of the Amendment by the directors and shareholders was June 20, 2002. The number of votes cast by the shareholders was sufficient for approval of the amendment. There is only one voting group entitled to vote on the amendment.
