

AMENDED AND RESTATED

ARTICLES OF INCORPORATION

OF

BHIDE AND HALL ARCHITECTS, P.A., A FLORIDA PROFESSIONAL ASSOCIATION



Pursuant to the provisions of Chapter 607 and 621, Florida Statutes, as amended, the undersigned Florida professional association adopts the following Amended and Restated Articles of Incorporation. This Corporation's Articles of Incorporation were filed on January 16, 1979; Document Number 606698.

ARTICLE I - NAME

The name of this Corporation shall be: Bhide & Hall Architects, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business of the Corporation is:

ARTICLE III - PRINCIPAL OFFICER

ARTICLE IV - DURATION

This Corporation commenced its existence as a Florida professional association on January 16, 1979. This Corporation shall exist perpetually.

ARTICLE V - PURPOSE

This Corporation is organized for the following purposes:

- (a) The practice of architecture; and
- (b) The transaction of any and all other lawful business for which professional service corporations may be incorporated, including but not limited to those powers pursuant to Chapter 607 and Chapter 621 of the Florida Statutes, as amended, and the doing of all lawful things related thereto.

This Corporation is authorized to issue fifty thousand (50,000) shares with a par value of One and NO/100 Dollars (\$1.00) per share. Each outstanding share, regardless of class, shall be entitled to one (1) vote on each matter submitted to a vote at a meeting of the Shareholders. The shares of stock may be issued for such consideration as is determined from time to time by the Board of Directors. Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.

Any and all powers and duties conferred to or imposed upon the Board of Directors, shall be by a resolution of the Shareholders and/or contained within the duly adopted Bylaws of the Corporation.

ARTICLE XII - AMENDMENT

The Shareholders reserve the right to alter, amend or repeal any provisions contained in these Amended and Restated Articles of Incorporation, or to adopt new provisions. These Amended and Restated Articles of Incorporation may be amended by a sixty percent majority vote (not less than 60.0%) of the voting stock of the Corporation that is present, at any regular meeting of the Shareholders or at any special meeting of the Shareholders called for that purpose, at which a quorum is present.

ARTICLE XIII - ADOPTION

These Amended and Restated Articles of Incorporation were adopted and approved by a unanimous vote of the Directors of the Corporation and a unanimous vote of the Shareholders of the Corporation, which was a sufficient number to approve these
