THE UNDERSIGNED, Philip Conte, as President and Secretary of National Plant, Shippers, Inc. a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby files the Corporation's Articles of Amendment to its Articles of Incorporation pursuant to a written action taken by holders of record of all issued and outstanding shares of the Corporation's single class of capital stock, and states that the number of such shares represented by those holders voting in favor of such amendment of the Corporation's Articles of Incorporation was sufficient for their respective approval by the Corporation's shareholders:

- 1. The Articles of Incorporation of the Corporation are hereby amended to reflect that the Corporation has changed its name from National Plant Shippers, Inc. to Phil Conte Enterprises, Inc.
- 2. The foregoing amendment to the Corporation's Articles of Incorporation was duly adopted by written consent of the holder of all shares of the Corporation's issued and outstanding common voting stock, in accordance with the provisions of Section 607.0704, Florida Statutes, and, by operation of subsection (5) thereof, not in contravention of the requirements of §§607.1003 or .1006, Florida Statutes, the consent providing the required majority in interest authorization for the proposed action being dated and received on January 5, 1999.
- 3. These Articles of Amendment to the Corporation's Articles of Incorporation shall become effective at the time of their filing by the Florida Department of State.
