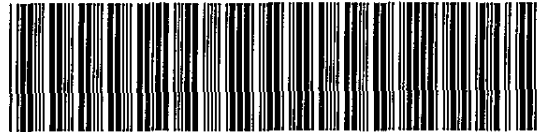

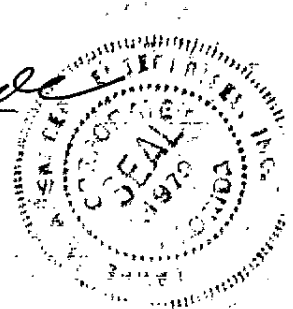
1. The name of the Corporation is LAWRENCE A. SANDERS ENTERPRISES, INC.
