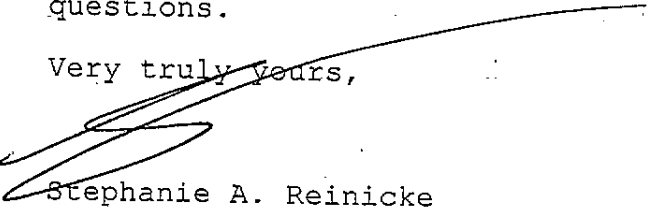

Enclosed, in connection with this matter, are the following:

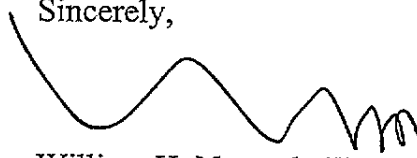

ARTICLE I

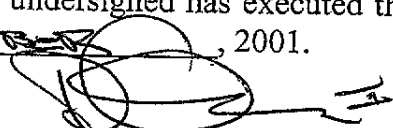
Name

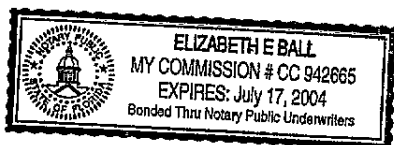
The remaining Articles of the Articles of Incorporation shall remain unchanged, unaltered and in full force and effect.

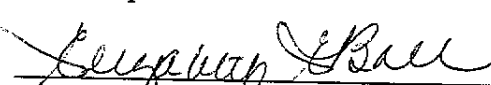
