ARTICLES OF AMENDMENT

to

ARTICLES OF INCORPORATION

of

Pursuant to Section 607.1001, Florida Statutes, the Articles of Incorporation of the above-named Corporation are amended as follows:

1. The first paragraph of Article III is amended to read as follows:

"The aggregate number of shares which the Corporation shall have the authority to issue shall be 700 shares of common stock, of which 70 shares shall be voting common stock and 630 shares shall be non-voting common stock.
