ARTICLES OF DISSOLUTION

OF

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporations Act, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving the corporation:

1. The name of the corporation (the "Corporation") is **CHARLES R. FREEBLE, III, M.D., INC.**

2. The dissolution of the Corporation was authorized on the 29th day of November, 2007, by vote of the holders of a majority of the outstanding common stock and by the members of the Board of Directors. The Corporation is authorized to issue only one class of common stock.

3. The number of shares of the stock of the Corporation cast for dissolution of the Corporation was sufficient for the approval of such dissolution.

4. The effective date of the dissolution of the Corporation shall be the date of filing these Articles of Dissolution with the Department of State of the State of Florida.
