# **ARTICLES OF INCORPORATION**



Pursuant to Chapter 607.1006, F.S., the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation, formerly known as TARRIMAR TRAILER AND EQUIPMENT REPAIRS, INC., shall hereinafter be known as:
