ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

Pursuant to Chapter 607.1006, F.S., the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation, formerly known as TARRIMAR TRAILER AND EQUIPMENT REPAIRS, INC., shall hereinafter be known as:

TARRIOS INVESTMENTS, INC.

SECOND: The following amendment to the Articles of Incorporation was adopted by the corporation:

ARTICLE I.

The name of this Corporation is:

TARRIOS INVESTMENTS, INC.

THIRD: Current shareholders shall surrender their shares of stock bearing the name, TARRIMAR TRAILER AND EQUIPMENT REPAIRS, INC., in exchange for identical shares of stock bearing the name "TARRIOS INVESTMENTS, INC."

FOURTH: The amendment was unanimously adopted by the shareholders on the 30<sup>th</sup> day of August, 2001, and accordingly, the number of votes was sufficient for approval of said amendment.

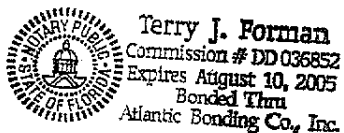
