AMENDED AND RESTATED ARTICLES OF INCORPORATION OF STARBRITE STA-PUT, INC.

The Articles of Incorporation of the Corporation are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the corporation is Starbrite Sta-Put, Inc.

ARTICLE II - PRINCIPAL OFFICE

The street and mailing address of the principal office of the corporation is 4041 SW 47 Avenue, Ft. Lauderdale, Florida 33314.

ARTICLE III - CAPITAL STOCK

Any amendment, repeal, or modification of this Article VI shall not adversely affect any right or protection hereunder of any person in respect of any act or omission occurring prior to the time of such repeal or modification.
