### AMENDED AND RESTATED

### ARTICLES OF INCORPORATION

OF

### PNW CORP.

Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation:

### ARTICLE I Name

ARTICLE II

Duration

The Corporation shall have a perpetual existence, unless dissolved according to law.

ARTICLE III

Purpose

The Corporation is organized form

orporation. The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, as amended and in force from time to time.

### ARTICLE IV Capital Stock

The Corporation is authorized to issue seven thousand five hundred (7,500) shares of one dollar (\$1.00) par value common stock which shall be designated "Common Voting Shares"; and seventy-five thousand (75,000) shares of one dollar (\$1.00) par value common stock which shall be designated "Common Non-Voting Shares." The Common Voting Shares and Common Non-Voting Shares shall be entitled in all respects to equal rights and privileges except that each share of Common Voting Shares shall be entitled to one (1) vote and each share of Common Non-

Voting Shares shall be Non-Voting stock.

# ARTICLE V Principal Office; Registered Office and Agent

The street address of the principal office and registered office of the Corporation is c/o 500 North Federal Highway, Pompano Beach, Florida 33062, and the name of the registered agent of the Corporation at that address is Peter Wolofsky.

### ARTICLE VI Miscellancous

1. The Corporation shall have one (1) directors. The number of directors may be increased or decreased from time to time by the By-Laws, but shall never be less than one (1). The names and addresses of the directors of the Corporation are:

- 2. The number of shares of the Corporation outstanding at the adoption was seven thousand five hundred (7,500), and the number of shares entitled to vote thereon was seven thousand five hundred (7,500).
- 3. The number of shares voted in favor of such Amendment was seven thousand five hundred (7,500), and the number of shares voted against such Amendment was none.
- 4. These Amended Articles of Incorporation were adopted on the  $\frac{77}{100}$  day of  $\frac{1}{100}$ , 2008.
- 5. The holders of Common Shares shall exchange each share of such stock for one (1) share of Voting Common stock and ten (10) shares of Non-Voting Common stock.
- 6. These Amended and Restated Articles of Incorporation shall become effective immediately upon filing with the Department of State of Florida.
