Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida for-profit corporation adopts the following articles of amendment to its Articles of Incorporation, originally filed on April 1, 1977.

1. The Shareholders have determined to change the name of the corporation as follows:

**"ARTICLE I
Name**

The name of the corporation shall be:

Primary Care Center of Port Orange, Inc."

2. Pursuant to 621.13 (3), the Shareholder has determined to change the business purpose of this professional service corporation from the rendering of professional service to provide for any other lawful purpose. All reference in the Articles of Incorporation to business purpose, and operation as a professional service corporation, and ownership of licensed physicians as a requirement are hereby deleted, and replaced with the following statement:

"The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida."
