



**SECOND ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
PRIMARY CARE CENTER OF PORT ORANGE, INC.,  
a Florida corporation**

Pursuant to the provisions of Section 607.1006, Florida Statutes, Primary Care Center of Port Orange, Inc., a Florida corporation (the "Corporation"), adopts the following Second Articles of Amendment to its Articles of Incorporation:

FIRST. Article I of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety to read as follows:

**"ARTICLE I  
Name**

SECOND. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged and in full force and effect.

THIRD.
